**NOTICE OF TENDER**

1. The office of Director Civil Works POF Wah Cantt invites sealed tenders (separately for each work) for the following works in the light of PPRA Rule 13(I) of 2004.

2. The contractors are required to submit their applications to Director Civil Works, D-10/1 Building, POF Wah Cantt upto 08-09-2017 for issuance of tender documents alongwith their complete credentials as shown at (Serial 4). Contractors who are on Active Taxpayers List (ATL) of FBR for Income Tax & Sales Tax and enlisted with Director Civil Works POF Wah Cantt are eligible to submit their applications.

3. Package-wise details of works may be confirmed from the office of undersigned in person during working days from 1000 hrs to 1300 hrs before 08-09-2017. However, salient features are as under:-

- a. Provision of B.B wall with barbed wire fence fixed on top in estate and factories areas where required.
- b. Repair of damaged B.B wall/block wall in estate and factories areas respectively where required.
- c. Raising of existing walls in estate and factories areas where required.
- d. Repair of damaged barbed wire fence in estate and factories areas where required.
- e. Replacement of prefab wall with B.B wall where required.
- f. Provision of new barriers where required.
- g. Provision of wire mesh fence where required etc.

4. Contractors having experience, capability and resources may submit the following information/documents alongwith their applications: -

- a. Name of the firm along with Postal Address, Phone & Fax #.
- b. Status of firm (Partnership deed, Article of association or Registration of firm's certificate etc).
- c. P.E.C Registration in C-6 for works at Sr. No. iii & iv and C-5 for work at Sr. No. i, ii, v, vi & vii. P.E.C Registration for year 2017 or P.E.C Registration for year 2016 alongwith the evidence of the submission of renewal fee for year 2017.
- d. Similar nature of works up to Rs 25.00 million completed during last three years.
- e. Similar nature of works in hand along with names and addresses of Clients.
- f. Proof of enlistment with Director Civil Works POF Wah Cantt or Proof of enlistment under process with Director Civil Works POF Wah Cantt.
- g. List of Key Personnel & Details of Technical staff.
- h. List of Machinery & Equipment Owned.
- i. NTN No. and evidence of as active tax payers on Active Taxpayers List (ATL) of FBR for Income Tax & Sales Tax.

5. Those who fail to provide above mentioned Information / documents shall be disqualified.
6. The applications shall be scrutinized and the tender documents will only be issued to the contractors who have sufficient experience in the relevant field and satisfied other special conditions required for the job and area. Tenders will only be issued to the scrutinized contractors upto 09-09-2017. Tenders will be received by the Director Civil Works POFs Wah Cantt upto 1100 hrs on 23-09-2017 and opened at 1130 hrs on the same date.
7. Contractors already registered/working with POFs submit only their applications alongwith PEC certificate, NTN No. and evidence of as active tax payers on Active Taxpayers List (ATL) of FBR for Income Tax & Sales Tax.
