- f. List of Key personnel & Details of Technical Staff.
- g. Provide last 3 year bank account statement of firm/company from a scheduled Bank Affidavit for Non-Blacklisted or involved in arbitration / litigation with any Client during the last five years.
- h. Pre-qualified for similar nature of works with Govt, Semi Govt/Private Firm.
- i. Proof of enlistment with other societies, union/town council preferably cantonment areas etc.
- j. provide detail of services already offered.
- k. Provide list of offered channels along with resolution details.
- l. Relevant experience minimum 5 years preferable in Cantonment Areas and having past performance to provide services.
- m. Firm / companies must have functional setup which would be inspected by concerned technical team, while evaluating bid.

- n. Feedback from clients where already services is being provided by Companies /Firm and same would be verified by Station HQ concerned technical team.
  - o. Any other related documents to support firm's credentials.
3. Those who fail to provide above mentioned information / documents shall be disqualified.
  4. Firms / company will be assessed on basis of their offered proposal, profile, capabilities and experience.
  5. Contracting agency may reject all bids or proposals at any time prior to the acceptance of bids or proposals. Furthermore, contracting agency may increase/decrease the scope of work on the basis of proposals received from the bidders.
